SCHOOL-PARENT COMPACT

4. Provide parents with reasonable access to staff through email, phone, and ParentSquare. Teachers will respond within 24 hours to communication requests and can set up meetings at times that are convenient for the parent and teacher.
5. Provide parents opportunities to volunteer and participate in their child's class, observe classroom activities, and attend field trips based on capacity.

- Monitoring the amount of screen time their children watch.

- Promoting positive use of my child's extracurricular time.
- Stay informed about my child's education and communicate with the school by promptly reading all notices from the school or the school district received by my child or by mail/email or ParentSquare, and responding as appropriate.

suggestions and participate, as appropriate, in decisions about their children's education. The school will respond to any such suggestions as soon as practicably possible.

7. Provide each parent with an individual student report about the performance of their child on the state assessment in at least math, language arts, and reading.
8. Provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002).
9. Recommend to the local educational agency (LEA), the names of parents of participating children of Title I, Part A programs who are interested in serving on the State's Committee of Practitioners and School Support Teams.
10. Notify parents of the school's participation in Early Reading First, Reading First, and Even Start Family Literacy Programs operating within the school, the district, and the contact information.
11. Work with the LEA to address problems in implementing parental involvement activities in section 1118 of Title I, Part A.
12. Work with the LEA to ensure that a copy of the SEA's written complaint procedures for resolving any issue of violation(s) of a Federal statute or regulation of Title I, Part A programs is provided to parents of students and to appropriate private school officials or representatives.
