Mountain View School Site Council By Laws

1. As per election results, the council will consist of equal representation and include parents/community members, teachers, administration and a member of the support staff.
2. A quorum of at least six members must be present in-person or virtually to conduct any council business.
3. Site Council agendas will be posted on the school website 24 hours prior to a meeting.
4. Meeting minutes will appear on the school website within 72 hours after a meeting.
5. Meetings at Mountain View will be completed within one hour, whenever possible.

6. Electronic voting /meetings may be utilized by the council for pending items that are time sensitive and must be resolved between regularly scheduled meetings. This procedure may also be utilized if the monthly agenda is very minimal in nature.
7. All decisions will be reached via majority vote. In the rare instance that a tie vote is the result, the Chair will cast the deciding ballot. This procedure however, will only be permitted if the item in question is deemed a priority that cannot be postponed.
8. Questions or input from the public will appear as the last order of business in each meeting. Anyone wishing to address the council will be allocated the opportunity to do so within the same time frame as the agenda item.
9. The Site Council can discuss issues of school policy and make written suggestions to the appropriate campus or district governing bodies regarding proposed changes. The council however, is not mandated to make any alterations to school, district, or state policies regarding any aspect of the education process.
10. The majority of the council's efforts will be focused on the collection and distribution of tax expenditures. It is recommended that staff members who are requesting funds attend the meeting to present their requests and answer any questions the Council may have. Requests for such funds will be analyzed and voted upon in each meeting. Funds are disbursed on a first come, first serve basis. The council reserves the right to reduce or deny requests based on circumstances or availability of funds.
